# **Key Takeaways & Recommendations**

1	Germany is the largest importer of hemp products under the HS codes 5302 and 530290. Germany is also the second largest market when it comes to products launched containing hemp.
2	Four other European markets are in the top 10 in terms of product launches. The vast majority of the top 10 importers of hemp under 5302 and 530290 are also European.
3	Whilst the US and Canada may be tempting, with the highest number of products launched and the fourth highest respectively, both are producers of large volumes of hemp themselves, with low levels of import likely due to this domestic dominance.
4	"Organic" is the most commonly used on-pack claim in hemp oil products, with "Vegan" and "GMO Free" becoming increasingly popular in recent years. For Vitamins/Dietary Supplement and Skincare "Botanical/Herbal" is the dominant claim.
5	61% of products containing hemp-based ingredients declare hemp seed. Hemp protein is cited in 23% of launches, with products containing hemp oil accounting for just 7% of the market.
6	Even in a developed market such as the US, consumers are confused about the difference between hemp and CBD. Mintel states that usage is still low, at around 10% of the population, which perhaps explains the confusion. On pack images of cannabis leaves are unlikely to help here also.

# **Methodology and Limitations**

### Methodology

Secondary market research based on publicly available sources and subscription databases such as Mintel's Global New Products Database (GPND).

• Mintel GPND covers 38,000 new product launches a month across 86 global markets. The platform displays images and detailed product information for launches in a wide array of categories.

### Limitations

•The information provided in this report was sourced from secondary data sources. Due to the nature of secondary research, all values and figures should be treated as indicative, rather than absolute.

•The latest information available at the time of research was used, however present values may differ.

•Mintel's Global New Products database is designed to give an overview of a given market and is not an exhaustive list of the products available.

# **Product Launches by Market**

# USA and Germany dominate in terms of product launches

- The USA and Germany are the most developed markets in terms of the number of products launched that contain hemp (no CBD).
- Five European markets (and UK) are inside the top ten, with large English speaking markets such as USA Canada and Australia making up the rest.
- Given South Africa's relative distance from other markets, this might be a challenging one to target.

# **Imports by Market**

# Germany imports almost double that of the next largest market

- Germany is the largest importer of hemp products worldwide.
- As with Spain (in second place), the majority of imports of hemp fall under the HS code 530290.
- Given that the US is such a large producer of hemp, it perhaps makes sense that Germany is importing so much more given the number of product launches.
- According to <u>this</u> report from New Frontier Data, the US mostly imports Hemp Seeds and Hemp Seed Oil Cake and other residues (see note below)

### **Germany's Imports by Market**

### France and Netherlands are Germany's main partners by significant margins

- Both France and Netherlands exported over 1.5 million USD of product to Germany under the HS code 5302 in 2019.
- This covers almost all of Germany's imports in the category.

Note: HS5302 is defined as: True Hemp, raw or processed but not spun; tow and waste of true hemp including yarn waste and garneted stock.

# Canada and China dominate in production terms

- In November 2019, Statista reported on this chart showing the acres of planted hemp by main markets.
- This shows that Canada dominated in 2017 but China planted nearly the same amount as Canada across the two years, despite hemp being something of a contentious issue in Chinese culture.
- The Wall Street Journal reported in 2019 that Marijuana is considered serious but the interest in CBD has encouraged China to up its production of hemp. In 2018, the production of hemp in China was larger than the US and the entirety of Europe – representing 11% of worldwide production.

# **Product Launches by Ingredient - Global**

# Hemp Seed is the most common ingredient in products containing hemp

- Looking at the worldwide picture, hemp product launches (excluding cannabidiols) are dominated by whole Hemp Seed, which represents around two thirds of the products launched.
- Hemp Protein is present in around 23% of launches.
- Hemp Seed Oil is still relatively rare as an ingredient, in 7% of product launches in this category.

# Claims (Top 10 markets) – Hemp Oil

# "Organic" is most important, with "Vegan" and "GMO Free" gaining share

- "Organic" is by far the most used claim in the Hemp Oils category across the top ten markets, with 60 of 116 products displaying this claim.
- The majority of these are certified organic but some appear not to display the certification.
- Developed markets will be subject to varying levels of scrutiny in terms of organic accreditation.
- Of the 116 products launched 2015-2020, 68 have claims, showcasing just how important "Organic" is to the category.
- "Vegan/No Animal Ingredients" is on an upwards trajectory, with "GMO Free" claims experiencing a sudden uptick in 2020.





# Claims (Top 10 markets) – Vitamins and Dietary Supplements

# "Botanical/Herbal" is the most common claim, followed by "Organic"

- In the Vitamins and Dietary Supplements segment, "Botanical/Herbal" and "Organic" are popular claims for products containing hemp.
- This is a point of difference for hempbased products in the category, with naturally derived products seen as an alternative to synthetic medicines.
- The prevalence of "Vegan/No Animal. Products with vegan casings could outperform those without in certain markets.

# Claims (Top 10 markets) – Skincare

### "Botanical/Herbal" is the most common claim, followed by functional claims

- Skincare is a category that generally ٠ relies on functional claims to aid consumer understanding, combined with value-added claims.
- "Botanical/Herbal" dominates here when looking at skincare products containing hemp, even more frequently used than the functional claim "Moisturising/Hydrating".
- Unlike in the other categories, ethical claims around animal testing and ingredients are also commonly used.

# Usage, Understanding and Curiosity in the US

# Clear messaging required to help consumers navigate the market

- Mintel conducted a survey in the US that suggests that hemp-producers must work to cultivate an identity separate to cannabis.
- Many hemp products contain images of cannabis leaves on pack which can be polarising, potentially off-putting to consumers who do not understand the differences between CBD and hemp.
- This lack of understanding is likely to be further emphasised in less developed markets.
- Clear messaging on pack will be especially important in this category.
