2006 Regulations and interpretation are not fit for purpose

The regulations have not meet their objective they have not enabled an industry, the interpretations of MOH have complicated the situation and business does not like uncertainty

We need the government to get out of the way or even better be supportive, then we are in a good place to scale up.

Removing uncertainty improves outcomes and reduces risk for investors and current industry participants to be involved

We don't want to waste money fighting the government, a pathway exists but they all end with THC (MODA) CBD (Medicines act)
