Progress update on meetings with the Government

We have received cross party support for the review of the iHemp Regulations, which is required to finally "enable" our industry.

Encouraging feedback has been received from various ministries, who all agree a "full review" of the regulations is required.

On 21 November 2024, we made a presentation to the Primary Production Select Committee, which summarises the discussion we have been having with MPs and officials.

A recording is available <u>here</u>; the briefing covered:

- Remove low THC from Misuse of Drugs Act and Medicines Act; we are not a drug!
- Full plant utilisation: access to revenue from all parts of the plant is a must for the industry to develop.
- Allowing a horticultural industry growing female plants for leaf and flower as food and natural health hemp products is the key to achieving export success.
- The ACVM is stopping hemp products being used by production and companion animals due to the trade issues around CBD and THC. We need a process to allow industry to get involved in these markets.
- Export potential and joining up various sectors, iHemp industry collaborating with NZ Inc, the R&D ecosystem, and government, to bring them all together over common ground
- Role of Government they can start by getting out of the way! They can get involved by supporting the creation of foundational knowledge for the industry to commercialise and providing a level playing field with "enabling" regulation.
- Government support would remove uncertainty and allow investment and job creation in the regions.
- Low risk: iHemp THC levels are so low it has little or no risk; therefore, we require a very light regulator touch. Or even better, no regulations at all for low THC iHemp as defined by the 2006 regulations.
- The Government promises made in 2006 to review the regulations, move us to another ministry, and adopt an enabling interpretation of the regs must happen in 2025.

NZ iHemp Industry statistics - Number of licences and area grown by region and variety

The 2023 / 2024 NZ iHemp Industry Statistics: We have received the response to our Official Information Act (OIA) request regarding the statistics for the growing season

Here is the high level review:

The year-by-year comparison data is <u>here</u>, and this year's OIA response is <u>here</u>.

Noticeably the numbers are pretty consistent with last year, with similar area grown and number of licenses. 87% of the hectares grown are in the South Island: Canterbury 70 hectares, Southland 30, and Nelson 56. The 13% in the North Island was mainly in Hawkes Bay, 24 hectares.

<u>Part II of the summer media campaign</u>: Getting regulations changed to allow a new horticultural industry!

The NZHIA's #1 aim is to get out of MODA, and the first step is to have a "full review" of the iHemp regulations. In Part II, we zero in on the review of the regulations and the need to take action by encouraging our letter-writing campaign.

We are currently handcuffed by the Ministry of Health; the compliance and uncertainty are putting investors and farmers off being involved. To grow we need regulations that work for farmers, businesses, and investors.

This requires fit-for-purpose regulations, and a review is way overdue!

With the success of the letters to the Ministry of Regulation and our meetings with MP's, ministries, and officials, we are making good progress, and there is considerable goodwill for a review.

We learnt from the meetings with MP's that if they receive even a couple of letters from their electorate, they are encouraged to look into the topic/issue. So the big push for Part II is to get the Hemp Army involved, take action, and be part of our letter-writing campaign to make first contact with your Local MP's and mayors and identify regions and communities that want a local iHemp industry.
